OUR UNIT WAS TRAVELING N.E. ON LOOP 375, HE EXITED AT RAILROAD DRIVE. BASED ON THE EVIDENCE OF MY INVESTIGATION, THE DRIVER STARTED INTO THE CURVE GOING TOO FAST. I THINK HE GOT ON HIS BRAKES VERY HARD, THEN GOT BACK OFF OF THEM. AS HE GOT ABOUT 1/2 TO 3/4 AROUND THE CURVE (STILL GOING TOO FAST) THE SURGE AND SLOSH FACTOR CLIMBED THE WALLS OF THE TANK ROLLING THE UNIT OVER ONTO IT'S LEFT SIDE AND COMING TO REST UPSIDE DOWN. THERE ARE 2 PRIMARY CONTRIBUTING FACTORS, 1ST IS THE UNITS SPEED, 2ND THE TRAILER WAS A 9500 GALLON CAP. TRAILER, THE DRIVER HAD ONLY LOADED 7300 GALLONS OF DIESEL. THE DOWNLOADED COMPARTMENTS CONTRIBUTED TO AN EXCESSIVE AMOUNT OF SLOSH AND SURGE.
