Describe:

Our employee apparently suffered a seizure and became unconscious while offloading from a parked DOT cargo vehicle to a stationary commercial ASME propane tank at a customer location. This allowed the stationary ASME tank to continue to fill and the pressure relief valve on the stationary ASME tank to relieve and reset multiple times until a rep from the customer found our employee, secured the pump from the DOT vehicle by activating the emergency shut down and calling 911. The tank was then filled to capacity and an evacuation and road closure ensued until a crew was brought on site from AmeriGas and pumped the tank down to an acceptable level.
