OUR APCI DRIVER NOTICED A PLUME AT THE REAR OF THE TRAILER WHILE TRAVELING ON VA ROUTE 360. HE PULLED OVER TO INVESTIGATE AND FOUND THAT THE LIQUID LEVEL GAUGE LINE HAD BROKEN OFF AT THE BULK HEAD. THE DRIVER NOTIFIED A MECHANIC AT A NEARBY CUSTOMER STATION AND TOGETHER THEY COMPLETED A TEMPORARY REPAIR. THE PRODUCT WAS TRANSFERRED TO ANOTHER TRAILER AND SUBSEQUENTLY OFF LOADED AT OUR CUSTOMER. THE BROKEN LINE WAS FOUND TO HAVE BEEN CAUSED BY VIBRATION AND METAL FATIGUE. THE LINE WAS REPLACED AND THE UNIT WAS PUT BACK INTO SERVICE.
