WHILE DRIVER ON INTERSTATE 10 EASTBOUND DRIVER HIT ROAD DEBRIS WHICH CAUSED A TIRE TO BLOW OUT ON VEHICLE. DRIVER PULLED VEHICLE TO THE SIDE OF THE ROAD AND DISCOVERED A FIRE HAD STARTED. THE LOCAL SHERIFFS DEPARTMENT RESPONDED TO ASSESS THE SITUATION. THE TRAILER CONTAINED 44092 POUNDS OF PARAFORMADEHYDE. APPARENTLY A LARGE AMOUNT OF PRODUCT BURNED ALONG WITH THE TRAILER. MILLER ENVIRONMENTAL OF SULPHUR LOUISIANA WAS DISPATCHED TO PERFORM THE CLEAN UP OF THE REMAINING FREE LIQUID WHICH INVOLVED THE REMOVAL OF RINSE WATER USED TO EXTINGUISH THE FIRE AND THE EXCAVATION OF SOIL FROM THE AFFECTED AREA. SIX (6) ROLL OFF DISPOSAL. THERE WERE NO INJURIES OR EXPOSURES REPORTED.
