Describe:

Driver Loaded at Motiva, Convent, LA and drove to Mosaic, Uncle Sam LA. He hooked up to unload, opened the discharge valve then the vent valve to start the unloading process. When he opened the vent valve there was still pressure in the tank and misted sulphur onto the top of the trailer. He shut down both valves and called dispatch for repair. Phone conversations with dispatch and mechanic determined the repair needed to be done in the shop and requested driver to unhook. Driver double checked valves to make sure they were closed, then unhooked unloading hose from trailer. Product leaked from the trailer discharge line due to a defective valve not closing.
