Vehicle was traveling south on US 181. Vehicle left the right side of the roadway due to inattention/distraction by the driver. Upon corrective action, vehicle rolled onto the passenger side and slid partially off the road. The roadway was partially blocked as a result of the crash. The tank trailer was damaged in three places resulting in a discharge of contents.
