THE TANK SHELL WAS RUPTURED ON BOTH SIDES BY THE COUPLER OF AN ADJACENT CAR. THE EXACT NUMBER OF EVACUEES HAS NOT BEEN DETERMINED. THE CAUSE OF THE DERAILMENT REMAINS UNDER INVESTIGATION.
