THE PRODUCT PURITY 3/8" SAMPLE LINE WITH A 3/8" THIN WALL BRASS NIPPLE BROKE AT THE THREADS UPSTREAM OF THE VALVE. LIQUID OXYGEN WAS EMITTED THROUGH THE SAMPLE LINE UNTIL THE VALVE WAS RE-INSTALLED ON THE LINE. THE TRAILER WAS PARKED IN A REMOTE AND ISOLATED AREA AS TO AVOID PERSONNEL AND OTHER VEHICLES. THE 3/8" THIN WALL BRASS NIPPLE WAS REPLACED WITH A THICK WALL 3/8" STAINLESS STEEL NIPPLE.
