AFTER BEING CLASSIFIED INTO A BOWL TRACK, THIS CAR WAS FOUND TO BE LEAKING FROM A SPLIT IN THE TANK CAR TANK. APPARENTLY FORCES RESULTING FROM COUPLING INTO CARS ALREADY HUMPED IN TO THE TRACK CAUSED THE FAILURE AT THIS WEAKENED POINT. A STREAM OF ACID WAS ARCHING FROM THE SPLIT TO THE GROUND. ATSF RESPONDERS CAREFULLY APPLIED TWO OAK WEDGES TO RESTRICT THE MATERIAL TO A FLOW RATE OF LESS THAN ONE GALLON PER HOUR. IN ADDITION, A CONTAINER WAS THEN POSITIONED TO CATCH THE SMALL FLOW OF PRODUCT. THE CAR WAS OFF LOADED INTO TANK TRUCKS FOR DELIVERY (COMPLETED AT 1400 ON 12/5). SUBSEQUENT INSPECTION REVEALED A 3/4" WIDE SPLIT ABOUT TWO FEET BELOW THE CAR'S CENTERLINE, AND ABOUT 2" FROM A SIDE LADDER BRACKET. IT WAS NOT ASSOCIATED WITH ANY OTHER WELD. INDICATIONS WERE THAT THE RUBBER INNER LINER HAD FAILED AND THEREBY PERMITTED PRODUCT TO REACT WITH THE TANK UNTIL THIS FAILURE OCCURRED.
