While switching Braskem facility tank car the safety relief device functioned on tank car UTLX 910108 . Car was stopped and valve re-seated. Car was left on track overnight and was checked for leakage by a UTLX mobile shop the following morning. No release was detected at tank pressure of 215psi. Car was placed on rack and unloaded. Customer told to de-pressure the car and apply for OTMA to move to shop.
