THE TRUCK WAS LOADED IN MCALESTER AT RAM, INC, FILLED WITH BULK PLANT WITH 5000 DYED DIESEL. THE TRUCK HAD A BLOWN TIRE AND HAD THE TIRE REPLACED AT DOW, OK. THE DRIVER AND THE TIRE REPAIRMAN SAW NO LEAKAGE OF FUEL AFTER THE TIRE WAS CHANGED. AFTER LEAVING MCALESTER THE BLOW OUT TIRE WAS PROBABLY THE CAUSE OF A VALVE BREAKAGE. THE VALVE FELL FROM THE TRUCK AND THE CARGO FUEL ESCAPED INTO THE ROAD WAY.
