A ONE VEHICLE ACCIDENT JUST OCCURED ON US HWY 62-412; THE WESTBOUND LANE OF TRAFFIC WAS PARTIALLY BLOCKED. V-1, FAILLA, WAS TRAVELING WEST ON US HWY 62-412. V-1 HAD STOPPED TO YIELD FOR TRAFFIC AHEAD OF HIM. V-3 ROC, AND V-4 MAGNESS, WERE BOTH TRAVELING EAST ON US HWY 62-412. V-3 AND V-4 WERE BOTH TRAVELING PAST THE ACCIDENT SCENE THAT JUST OCCURED. V-2 GULUTZO WAS TRAVELING WEST ON US HWY 62-412. V-2 TRAVELED AROUND THE CURVE ON THE WET HIGHWAY, SAW V-1 STOPPED IN THE ROADWAY, BEHIND THE FIRST ACIDENT. V-2 APPLIED HIS BRAKES TO STOP, SLID SIDEWAYS CROSSING INTO THE EAST BOUND LANE, COLLIDING INTO THE LEFT SIDE OF V-3. V-3 SPUN SIDEWAYS INTO A PRIVATE DRIVEWAY AND CAME TO REST FACING NORTH. V-2 CONTINUED TO SPIN ON THE ROADWAY, WITH THE REAR OF HIS TRUCK COLLIDING WITH V-1. V-1 ROLLED FORWARD AND CAME TO REST IN THE NORTH DITCH, FACING NORTH. V-2 CONTINUED TO SPIN OUT OF CONTROL ON THE HIGHWAY, COLLIDING WITH V-4 IN THE LEFT REAR SIDE. V-4 SPUN AROUND AND INTO THE DITCH ON THE SOUTH SIDE, AND CAME TO REST FACING NORTH. V-2 CONTINUED TO TRAVEL OUT OF CONTROL AND TRAVELED INTO THE SOUTH DITCH COLLIDING WITH AT TREE, SPINNING AROUND AND CAME TO REST AGAINST ANOTHER TREE, FACING NORTH. GULOTZO NUCO2 DRIVER HAS ATTENDED MIDSOUTH SAFETY COUNCIL SAFE DRIVING COURSE PRIOR TO RETURNING TO WORK.
