THE KENAN TRANSPORT LLC UNIT WAS TRAVELING WESTBOUND ON HIGHWAY 190 AND ATTEMPTING TO MAKE A RIGHT TURN INTO THE CUSTOMER LOCATION AT 15514 HIGHWAY 190 COVINGTON LOUISIANA. IN THE PROCESS OF MAKING THE TURN, THE TRAILER WHEELS WENT OFF THE ROADWAY INTO A DITCH. THIS CAUSED THE TRACTOR AND TRAILER TO OVERTURN. A VALVE ON THE TRAILER WAS DAMAGED WHICH ALLOWED LESS THAN 1 GALLON OF THE PROPANE TO BE RELEASED INTO THE ATMOSPHERE. LOCAL EMERGENCY PERSONNEL AND UNITED STATES ENVIRONMENTAL SERVICES RESPONDED TO THE SCENE AND HANDLED THE REMEDIATION. NO FURTHER ENVIRONMENTAL IMPACT IS ANTICIPATED.
