THE EPCO TRUCK, WHILE ENROUTE FROM MONROE, WI TO CHICAGO, IL ON I-90 EAST BOUND THE DRIVER OBSERVED THE TRAILER VENTING ABNORMALLY. THE DRIVER PULLED OVER ON THE SHOULDER OF THE OFF-RAMP LEADING TO I-290 EAST TO CHECK WHICH RELIEF VALVE WAS RELIEVING. IT WAS THE 3" MAIN RELIEF VALVE. THE 3" MAIN RELIEF VALVE SHOULD NOT RELIEVE UNTIL THE PRESSURE IN THE TRAILER VESSEL REACHES 350 PSIG. THE PRESSURE ON THE VESSEL AT THAT TIME WAS ONLY 230 PSIG. THE VALVE MALFUNCTIONED. THE DRIVER ATTEMPTED TO CAUSE THE VALVE TO RE-SEAT BUT WAS UNABLE. THIS VALVE MALFUNCTIONED AND WOULD NOT RE SEAT. THE VALVE CONTINUED TO VENT UNTIL ALL THE PRESSURE WAS OFF THE VESSEL. AT THIS TIME THIS VALVE IS UNDER INVESTIGATION.
