WE WERE IN THE PROCESS OF OFF-LOADING FERRIC CHLORIDE SOLUTION FROM OUR TANK TRAILER. APPROXIMATELY, 30 MINUTES INTO THE TRANSFER A LEAK DEVELOPED AT THE BOTTOM REAR OF THE TRAILER. THE RELEASED CHEMICAL WAS FULLY CONTAINED AND RAN INTO THE SITE'S SPILL DRAIN WHICH CAPTURES ANY RELEASED CHEMICAL. THE DISCHARGE ADAPTOR PLATE LINING FAILED WHICH CAUSED THE LOCATION TO CORRODE AND RUPTURE. THE ADAPTOR WAS REPLACED.
