It was reported that while a 275 gallon tote of UN3265 Rocima 586 was being loaded into the trailer and was punctured at the bottom and all 275 gallons will be released. It was reported that the release is in the back of the trailer and the asphalt below. No drains, soils or waterways were reported to have been impacted by the release. ERTS dispatched an environmental contractor who responded to clean and dispose of the released product.
