APPROXIMATELY TWO-HUNDRED-SIXTY-FIVE GALLONS OF FREE PRODUCT WAS RELEASED. THE RELEASE WAS DUE TO A PUNCTURE BY ADJACENT FREIGHT. PENCO PACIFIC ENVIRONMENTAL PERFORMED THE CLEANUP USING TYVEK SUITS, GLOVES, AND ABSORBENT. THE CLEANUP MATERIALS AND WASTE GENERATED WENT INTO SIX, FIFTY-FIVE GALLON DRUMS. PENCO PACIFIC ENVIRONMENTAL WILL COORDINATE DISPOSAL. NO INJURIES OR EXPOSURES WERE REPORTED. THE MSDS WAS REQUESTED AND RECEIVED. ALL FEDERAL, STATE AND LOCAL REGULATORY AGENCIES WERE NOTIFIED.
