### Describe:

Yard personnel reported ice buildup on the exterior of the protective housing and a strong odor behind the car. Code 3, contractor, was dispatched and upon arrival found the liquid valve open and the plug less than tool tight, resulting in liquid spraying out and freezing. A large chunk of ice was noted on the valve and housing walls. The valve was closed, the plug retapped and then properly secured with no other issues found. The car continued in transportation after the ice melted off.
