Describe:

On 8/27/2024, the BNSF Los Angeles hub personnel reported Unit ESTU 500350 (Waybill Hazardous) as leaking a substance from the middle of the container that did reach the ground after unit de ramped from a train. Unit was taken to the Hazmat Pit for safety. On the behalf of the shipper, approved

contractor United Pumping was contacted and dispatched to complete inspection.

Interior inspection revealed palatized cases, palletized gallon drums and 2 IBC Totes of Sulfuric Acid in 2 rows, stacked 2 high in the nose throughout

the container. Source of the leak was determined to be 2 IBC Totes in the middle of the unit. The cause for the Leak was determined to be 2 IBC Totes

appeared to have a pre existing creases near the top that caused the totes plastic to break, creating package failure contributing to the material leak.

Total quantity of leaked liquid was approximately 10 gallons of product, 5 gallons from each IBC Tote.
