The KAG Energy, LLC unit was traveling westbound on I 76 near Austintown, Ohio. The KAG Energy, LLC unit drifted off the roadway and struck an abandoned vehicle on the shoulder of the highway. The KAG Energy, LLC unit then went off the roadway and rolled over. Approximately 4572 gallons of cutback asphalt was released. The released product impacted a nearby stream and reservoir. Hepaco Environmental and Enviroserve are continuing to remediate the site.
