NS Intermodal ramp personnel reported an unidentified flammable liquid leaking from FDUX 536129. There was no impact to waterways and there was no injuries noted. It was determined that 1 of 4 totes was ruptured due to load shift and had leaked to empty. All of the contents were placed on poly next to the vessel. The tote in question was isolated and wrapped in poly.
