Describe:

Tank car CGTX 31178 was found in the West Colton Yard in Bloomington, CA with diesel down the sides of the tank car and between the manway and the combination housing. After assessment it was determined that the manway swing bolts were over tightened causing the manway to be misaligned, also, the safety eye bolt was offset/bowed from being over torqued causing product to release. The manway gasket was inspected, and no issues where found. The tank car manway was reset, and the swing bolts were secured properly. Contractor cleaned off all diesel impacted areas on the tank car.
