Loading material onto tanker 3003. Employees thought there was a lot more room left on the tanker than there was and didn't check levels on the tanker. This resulted in the tanker being overfilled and 300 gallons ending up in containment. Once employees found the spill and that everything was contained onsite they started the cleanup by pumping up the material in containment back into a waste tank and removing some more material from the tanker so it was not overfilled. All employees are hazwoper trained and able to cleanup spills onsite at the direction of the emergency coordinator for that shift which is the shift supervisor.
