Describe:

On July 8, 2024, at 1745 ET, Emergency Response and Training Solutions (ERTS) was contacted by Landstar personnel in Jefferson, Georgia regarding the release of Caustic Soda Prills. Contractors were dispatched to the site to perform all onsite clean-up activities. Upon arrival, contractors confirmed the release of Caustic Soda Prills (UN1823, 8, II). The release was caused by a rollover accident that impacted a 360ft x 50ft area of soil and an adjacent concrete lined drainage ditch that contained 635 gallons of free-standing impacted rainwater. Contractors collected the damaged cargo that was still in the trailer, neutralized and collected all free-standing liquid with a vac truck, excavated all impacted soil, then placed seed and straw. Contractors took 635 gallons of impacted rainwater in a vac truck and 11 roll-offs of impacted soil and damaged cargo offsite for proper disposal.
