NS train 18ML811 pulling east on Main #1 near Attica, OH derailed 20 cars. The derailment led to the release of 5800 gallons of "alcohols, n.o.s." from tank car TILX360188 due to 2 manway bolts being sheared off and the release of 20 gallons of alcohols, "n.o.s." from tank car TILX198831 from the closed BOV after the BOV nipple was sheared off. The total cost for both releases will be recorded on this report for TILX360188. The total cost estimate is \$3,600,00.
