Vehicle owned by Pilot Travel Centers LLC (PTC) was exiting I-283 onto I-83N, when another vehicle made a sudden lane change from the left and struck the PTC tractor. The contact caused the PTC driver to lose control of the vehicle and the vehicle subsequently struck a guard rail and overturned. As a result, the trailer shell was breached and approximately 4000 gallons of diesel fuel were released. Video of event was captured by in-cab cameras equipped on PTC vehicle.
