When tank car PROX 44601 was in the WLE Brewster Car Shop for routine repairs, the carmen used a gas detection meter to check the top of the car for leaks after noticing an odor coming from the car. When they inserted the gas meter inside of the protective housing, the gas meter gave an alarm. They called myself, John Vergis Environmental Officer for the WLE, to come out and look at the car. I determined that the Vacuum Relief device was leaking around the O Ring Seal. I have called the car owner to see how they want to proceed with repairs. As of 5-29-2024, I have not yet heard back from them.
