### Describe:

At 11:05 ET, XPO notified the Call Center of a cargo release at terminal ULA. It was reported that approximately 12 ounces of Henry Pumadeq Flex 31MV released from one 5-gallon metal pale due to improper loading. The release impacted trailer #3214929. Call Center reviewed the SDS with the caller and determined that terminal personnel are capable of cleaning the release with PPE available on site. Chemtrec has been notified Chemtrec Report #2024111800060, POC: Joanne. Waste label 222195-1 was created, 55-gallon poly drum, containing original container, shrink wrap and paper towels used during clean up.
