Describe:

A train crew reported a strong odor in the A-Yard. Upon inspection of the rail cars, it was discovered that UTLX 665609 had small drops on the chain and bottom outlet valve cap. This is also the area where the scent was the strongest. The ties and ground were dry under the rail car. Rybak Environmental Inc. was called in to assess the cause of the leak and make necessary repairs. The BOV cap was found to be not too tight. The product in the BOV cap was contained in a 5-gallon bucket and disposed of by Rybak. Furthermore, the handle securing pin bracket was bent preventing closure of valve. Rybak employees straightened the securing pin bracket to allow the internal valve to fully close. Vincent Leishman from the Federal Railroad Administration was also notified and followed up with an inspection during the process.
