Describe:

Empty LPG UN1075 residue car (GATX21086) was heard hissing and smelling of propane. SPSI was contacted and mobilized, arriving at 1230 hrs. SPSI met with Mechanical Manager Clinton Simons to obtain track protection for CN Runner track (616) via blue flag, brake set, switches locked. After safety briefing, SPSI crew climbed to top of car with MX4 to assess for leaks and applied Snoop around the PRD. It was determined the PRD was leaking. Crew used Indian Spring capping kit (64A) to cap off the PRD. Snoop was reapplied to verify there were no leaks present, waited 25 minutes before checking it again. No leaks were verified on the PRD. Clinton Simons was notified of findings, general housekeeping was performed of work area, and crew demobilized back to shop.
