### Describe:

PPRX 663916 was found in the BNSF Railway Hogkins yard leaking from the top of the car when the car was moved. Upon inspection, it was determined that PPRX 663916 was leaking from the manway and released approximately 1 gallon of product. A BNSF contractor was dispatched, inspected the car and found the manway gasket deteriorated and one of 6 manway swing bolts less than tool tight. The contractor installed a new manway gasket, properly secured the car and BNSF released it to destination.
